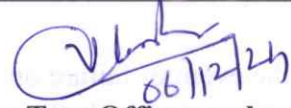

4. Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.
5. He/ She shall replant trees as per details given below during the ensuing/next planting season i.e. commencing from June 2025 to Sept 2025 in the property from where the trees will be felled.

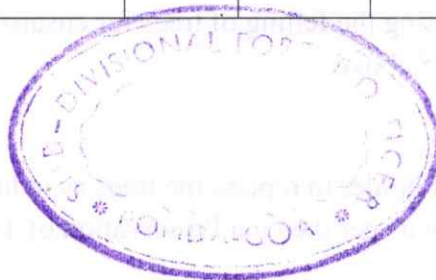

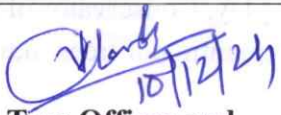
