2. Permission to fell trees is granted at his/her risk and without prejudice to claim(s) of any other Person/s who may be having right/s over the land or the trees.
3. The actual tree felling shall be carried out after 30 days from the date of issue of this tree felling permission as per the directions of Hon'ble High court in PIL Writ Petition No. 08 of 2021. The tree felling may be completed within 45 days after completing 30 days as mentioned above, In case trees felling not completed within 45 days application for extension of time limit for felling of trees, shall be forwarded to this office through concern Range forest Officer.
4. Material produced from the felled trees shall not be removed or disposed without permission of the Tree Officer.
5. License fee was paid earlier vide R. No. 884/43 dtd. 18.12.2024 for Rs.8,00/-
