Sub.-Permission for cutting of trees in property under Sy. No. 104/1-A, at Ella village Tiswadi taluka.

Sir,

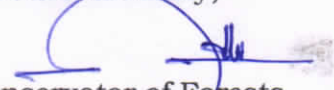
With reference to your letter dtd. 08/05/2025 on the cited above subject and permission of Forest Department is hereby conveyed for felling of 48 Nos. of trees under Sy. No. 104/1-A, at Ella village Tiswadi taluka, subject to following Terms and Conditions:-

1. In case of any claim/litigation about the ownership of the trees/land in question, the user agency will be solely responsible.
1. The cutting of tree shall be carried out after receipt of all other statutory permissions from competent authority, as applicable.
2. Date of beginning for felling of tree is to be intimated to Range Forest Officer, Panaji well in advance.
3. A separate register showing details of felling (like tree No, number of logs made out of each tree etc.) needs to be maintained by the user agency. The same shall be produced to the officer inspecting the site.
4. The actual tree felling shall be carried out after 30 days from the date of issue of this tree felling permission. The tree felling may be completed within 45 days after completing 30 days as mentioned above. Incase tree felling not completed within 45 days' application for extension of time limit for felling of trees, shall be forwarded to this office through concern Range Forest Officer.
6. To compensate the loss User Agency/Applicant is hereby advised to plant tall saplings with good endurance with minimum 8-10 feet height and 10cm diameter at 1 mtr. Height from ground level along the Highways, wherever is possible.
7. The Applicant/User Agency should replant 144 Nos. of tree saplings in lieu of felling of 48 Nos. trees.

User Agency has submitted Rs. 54,400/- Vide Cheque No. 000047 dtd. 08/05/2025 of Kotak Bank, Ponda Branch, Rs. 54,400/- vide UPI transaction No. 549486050033 dtd. 08/05/2025 through Cananra Bank and Rs. 54,400/- vide UPI transaction No. 549427745645 dtd. 08/05/2025 through Bank of Baroda, towards Tree felling fees and Security Deposit in favor of "Tree Protection Fund-Goa" and the amount of Security Deposit is refundable on compliance of replantation of 144 Nos. of trees.
