CONDITION OF AUCTION SALE:

1. The intending bidder shall inspect the logs prior to Auction day. Range Forest Officer, Timber Depot Tisk Usgao may be contacted on Mob No.8605275877.
2. The intending bidder shall have to deposit Rs.2000/- (Rupees Two Thousand only) as E.M.D. before the commencement of auction. The E.M.D. will be adjusted towards the 25% Payment in condition 2 for the successful bidder. The E.M.D. of non-successful bidders will be returned after the completion of auction.
3. The successful bidder should deposit 25% of the bid amount; otherwise the E.M.D. will be forfeited to the Government.
4. The remaining amount of 75% should be paid within 15 day of approval of bid, failing which the material will be re auctioned at the risk and cost of successful bidder and earlier deposited amount will be forfeited to the Government.
5. The material shall be lifted within 45 days of the approval of bid. If the same lot is not lifted within 45 days and the goods are not cleared. Penalty of Rs.1000/- per cubic meter per week will be charged for the next 4 weeks.
6. If the material is still not lifted within 90 days after bid approval the auction will be set aside and the entire amount of the bid will be forfeited to the Government.
7. The intending bidder should produce copy of income tax paid for last 3 Financial Years and copy of PAN card, GST registration etc. before auction.
8. The successful bidder shall have to pay 18% GST on forest produce and 2.5% Income Tax on Timber and Firewood.
9. Decision of the Dy. Conservator of Forests, North Goa Division, Ponda will be final on acceptance of the bid for lot or in dropping out any lot from the auction.
