Incase trees felling not completed within 45 days' application for extension of time limit for felling of trees, shall be forwarded to this office through concern Range Forest Officer.**
4. **Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.**
5. **He/She shall replant trees as per details given below during the ensuing/next planting season in the property from where the trees will be felled.**
