In case tree felling not completed within 45 days application for extension of time limit for felling of trees, shall be forwarded to this office through concern Range Forest Officer.**
4. Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.
5. He/ She shall replant trees as per details given below during the ensuing/next planting season i.e. commencing from June 2026 to Sept 2026 in the property from where the trees will be felled.
