5. He/ She shall replant trees as per details given below during the ensuing/next planting season i.e. commencing from June 2026 to Sept 2026 in the property from where the trees will be felled.

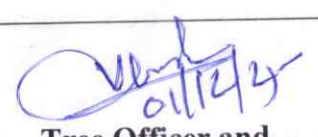
