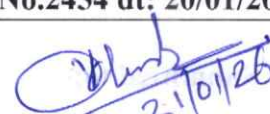

The tree felling may be completed within 45 days after completing 30 days as mentioned above. In case tree felling not completed within 45 days application for extension of time limit for felling of trees, shall be forwarded to this office through concern Range Forest Officer.**
4. Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.
5. He/ She shall replant trees as per details given below during the ensuing/next planting season i.e. commencing from June 2026 to Sept 2026 in the property from where the trees will be felled.

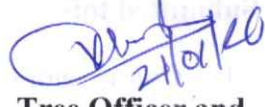
