4. Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.

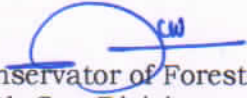
TERMS AND CONDITIONS

Incase trees felling not completed within 45 days' application for extension of time limit for felling of trees, shall be forwarded to this office through concern Range Forest Officer.
4. **Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.**
