Conservator of Forests, before starting the felling of trees for ensuring the Replanting of trees indicated as serial No. 5 above.
7. In the event of failure on the part of permit holder to replant the trees as indicated above, the Trees Office shall take necessary action as per the Goa Preservation of Tree Act 1984.
